By-Laws of San Juan Lodge, No. 175 F & AM of Washington

Article I Name

The name of this Lodge shall be San Juan Lodge No. 175, F&AM of Washington.

Article II Communications

- **Section 1**. The Stated Communications of this Lodge shall be held on the first Wednesday of every month, except in July and August, at 7:30 p.m. When this Stated Communication falls on the first day of January, this Stated Communication shall be held on the second Wednesday of January at 7:30 p.m.
- **Section 2.** All communications of this Lodge shall be held in the San Juan Masonic Lodge, at the address of $15 2^{nd}$ Street South, Friday Harbor. Washington 98250.

Article III Fees and Dues

- **Section 1.** The fee for the three degrees shall be \$120 and in addition, any fees required by the Grand Lodge which must accompany the petition.
- **Section 2.** If for any reason it becomes necessary to segregate the fees, the fee to accompany the petition for an Entered Apprentice and Fellowcraft Degrees shall be \$80.00 plus any additional fees required by the Grand Lodge. Should this Mason want to receive the Master Mason degree, he would be charged an additional \$40 plus any additional fees required by the Grand Lodge.
- **Section 3.** The fee for affiliation shall be \$10.00 plus any additional fees required by the Grand Lodge.
- **Section 4.** The annual dues of each member shall be \$100.00, which shall include the Grand Lodge annual assessment, and paid to the Lodge on/before the first day of January.

Section 5. Life Members of this Lodge shall be responsible for paying the Grand Lodge assessment to the Lodge on/before the first day of January each year, except those members designated exempt by the Grand Lodge of Washington.

Section 6. The annual amount levied by the Grand Lodge for each member under Section 7.03 B.L. of the Washington Masonic Code shall be assessed each member as part of the Lodge annual dues. This Lodge assessment is payable on/before the first day of January each year. Members exempt per section 7.03 B.L. of the Washington Masonic Code are not required to pay this assessment. (Date: Of-Of-OF) Initials (Secretary)

ARTICLE IV. Standing Committees

Section 1. The three principal officers of the Lodge shall constitute the Executive Committee.

Section 2. The Senior Warden, Junior Warden, and Secretary shall compose the Finance Committee. No claim or warrant shall be paid until first referred to this committee unless it is accounted for in the adopted line item budget of the Lodge, except as provided in Article V.

ARTICLE V. Charity

The Worshipful Master is empowered to draw on the Treasurer for sums not to exceed \$200.00 for each draft for the relief of indigent members of the Lodge or their families, and shall report the same to the Lodge at the next Stated Communication.

ARTICLE VI. Amendments

Amendments to these By-Laws shall be proposed in writing at a Stated Communication, and if adopted by a 2/3s vote of all members present at a subsequent Stated Communication, shall be immediately effective when approved by the Grand Master, whose action shall be conclusive.

Standing Resolutions/Rules and Wills/Bequests

Resolution/Rule #1: The San Juan Masonic Temple Association shall retain title and ownership of all real property and personal property belonging to San Juan Masonic Lodge #175, Friday Harbor, Washington.
